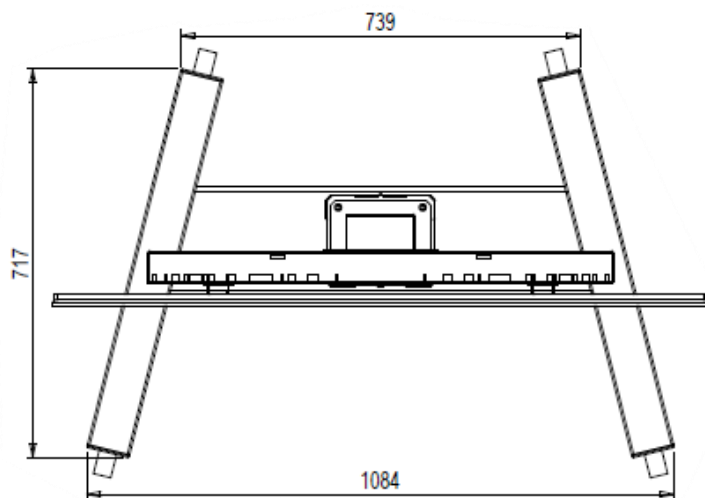
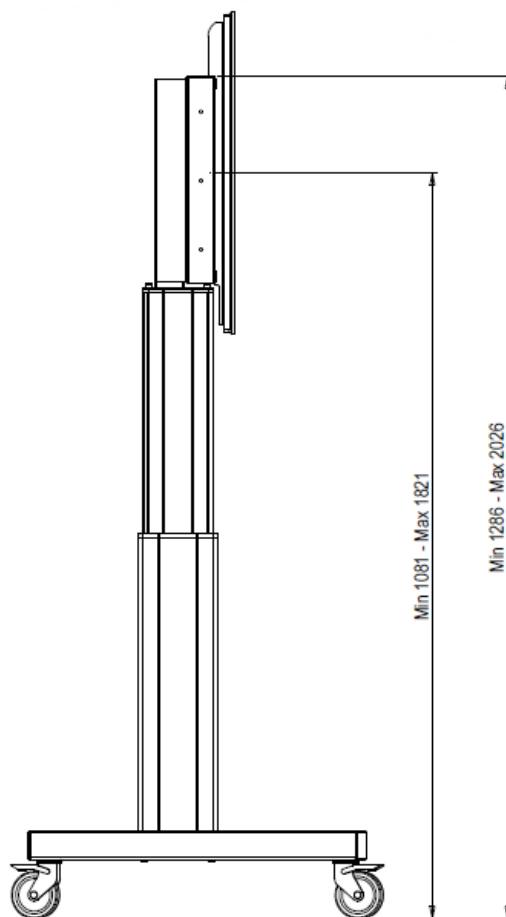
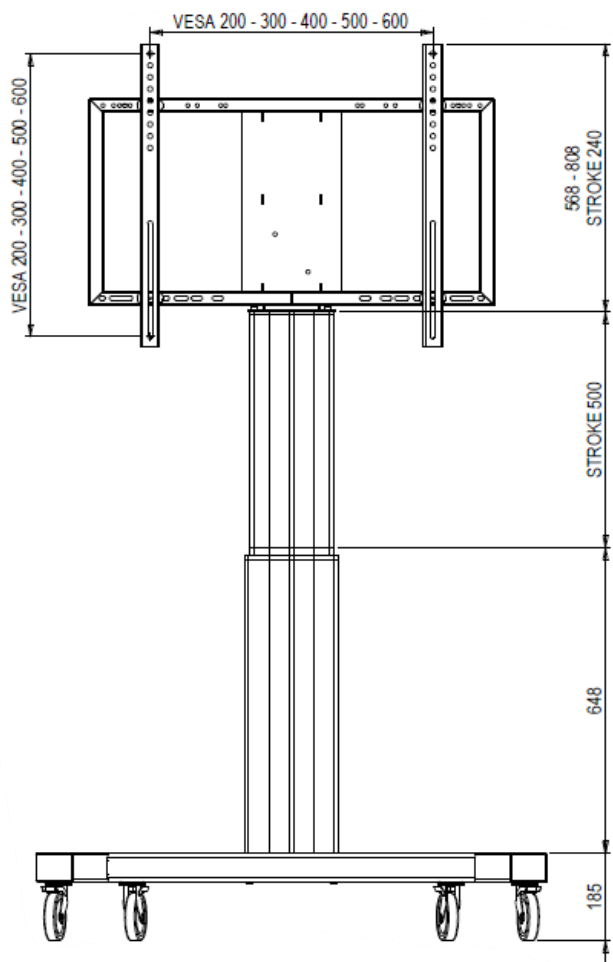

Before using the TROLLEY E500 MAXI, please read the following information regarding safety so as to safeguard the integrity of the product and avoid accidents.

DANGERS OF UNSTABLENESS

Use the product only on flat stable surfaces.

MECHANICAL DANGERS

Before activating the product, make sure that there are no obstacles or persons within a 25 cm range so as to avoid points of compression or entrapment. In case of accidents release the remote-control button in order to instantly stop the movement.

Do not overload the product. Only install the equipment specified (tv screen, board, interactive board, interactive screen). Do not exceed the maximum weight limit. Serious risk of injury in case of tipping over or incorrect use of the product.

ELECTRICAL DANGERS

Do not open the product – risk of electrocution.

Only connect to a 100-240V- 50-60 Hz grid with regular grounding system.

Only use in dry places and do not expose to rain or other liquids.

Clean only with a dry cloth.

In case of malfunction, pull the plug out of the socket before intervening.

Do not pull the electrical wire or damage it. In case of damage substitute it immediately with a new one of the same type.

MINIMUM SPACES FOR USE

Do not use the product in a space smaller than mm 2400x1600x2200h.

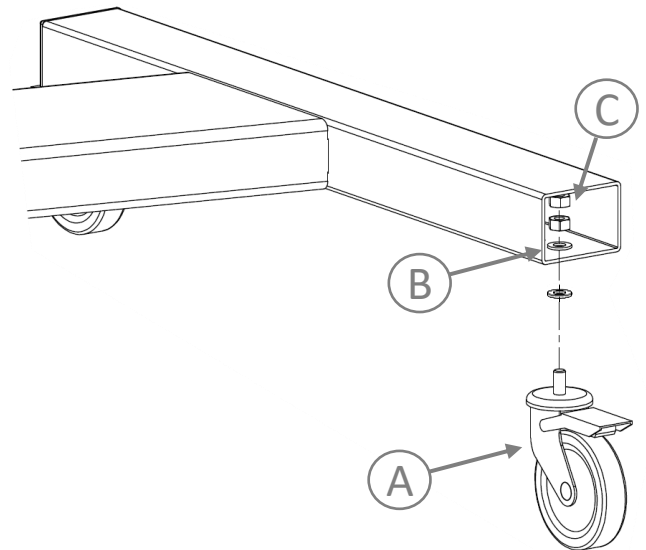
ASSEMBLY PROCESS

TRANSPORT AND ASSEMBLY

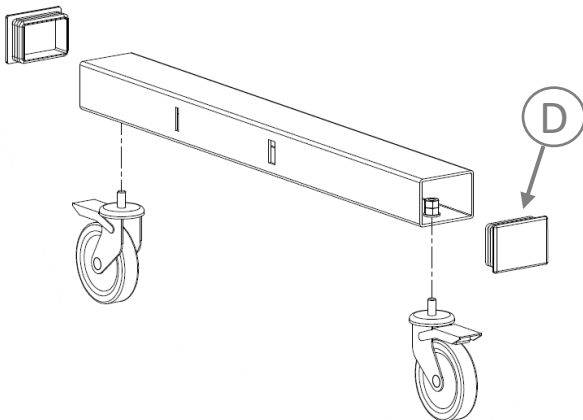
This motorized adjustable cart is supplied unassembled. Two people are required for assembly. The correct final installation is illustrated here below. Since the weight of the packed column is about 34 kg, the lifting and the transport should be done with a forklift or similar equipment, or carried by two people simultaneously.

WHEELS ASSEMBLY

For each wheel (A), use 2x washer M10 (B) plus 2x nut M10 (C) as indicated in the picture.

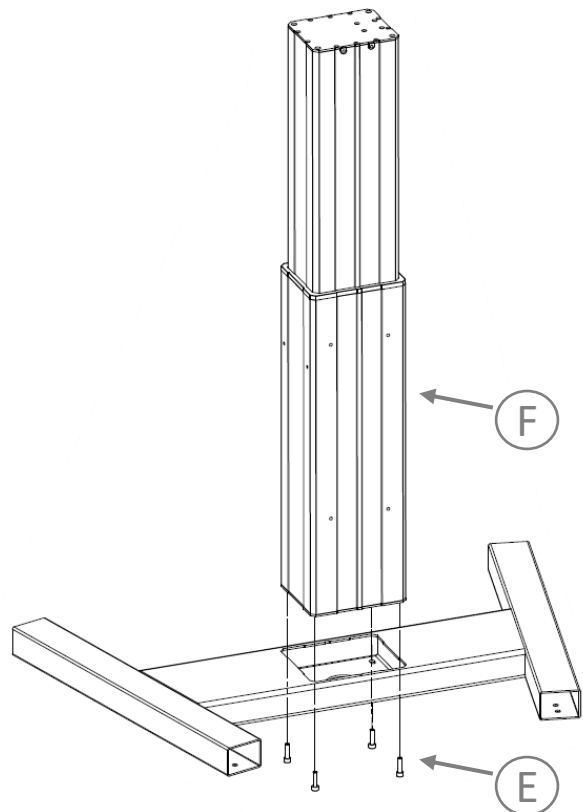


Insert 4x plastic caps (D) to the base



ELECTRIC COLUMN ASSEMBLY

Use 4x screws M10x30 (E) to fix the Electric Column (F)



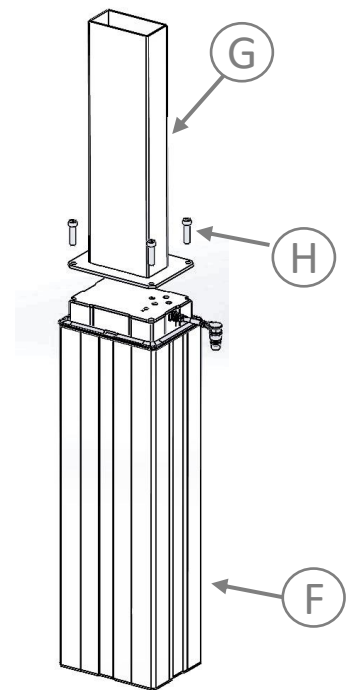
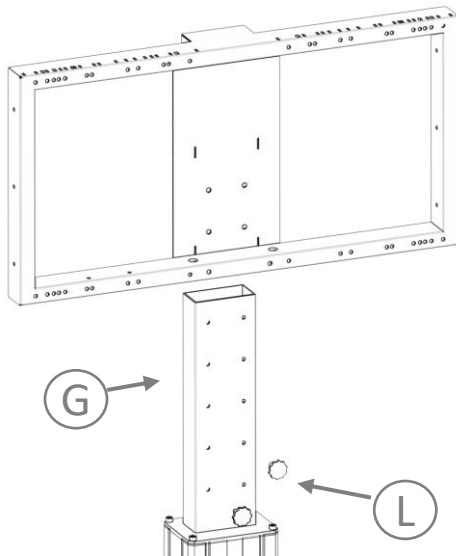
ASSEMBLY PROCESS

MOUNTING THE UPPER PART TO MOTORIZED COLUMN

Fix the main tube (G) to the column (F) using 4 screws M10x30 (H).

VESA SUPPORT INSTALLATION.

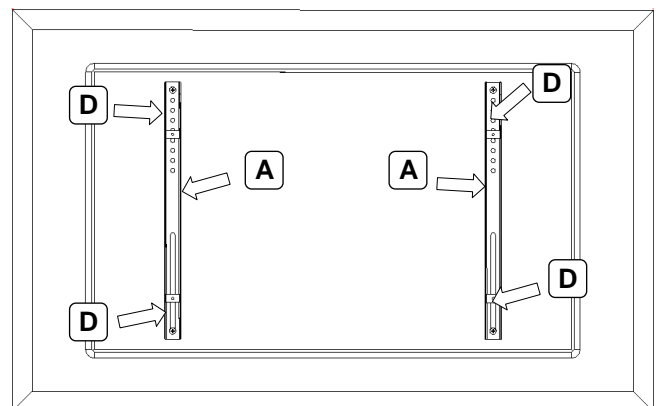
Insert the VESA support (I) into the tube (G) and position it at the desired height, then fix the VESA support with the two available screws (L)



ASSEMBLY THE SCREEN TO VESA SUPPORT

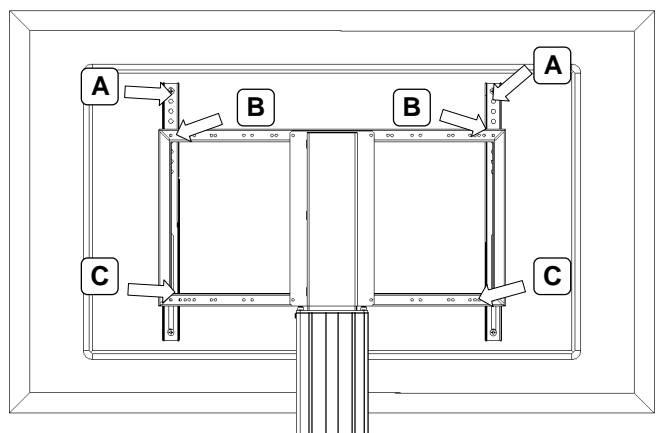
Use 4 x slotted screws

Place the brackets (A) equidistant from the center according to the screen holes, then fix them with the four specific screws (D) indicated by the screen manufacturer in the mounting instructions.



Use 2x allen screws M6X70 mm length

Place the screen hooking the brackets (A) into the appropriate holes (B). Secure the brackets with the two allen screws provided M6x70 (C).



ASSEMBLY PROCESS

ELECTRICAL CONNECTIONS

Connect according to the system diagram and then power on (input AC is 110-220VAC).

Up button: Press and hold the key to lift the column. Let go and stop.

Down button: Press and hold the key to lower the column. Let go and stop.

Matters needing attention

1. The system is energized, do not allow to open the controller, touch any live components, to prevent electric shock;
2. For products with protection grade below IPX6, water washing is not allowed to prevent the products from entering water and affecting the use. Only simple surface wiping can be carried out;
3. Without the guidance of professional personnel, it is not allowed to reform the product to prevent system abnormalities;
4. If the use of lead-acid battery or lithium battery products, lead-acid battery in the warehouse for 3 months without use, you need to carry out charge and discharge maintenance, lithium battery for 6 months without use, you need to charge and discharge maintenance, to prevent battery damage or shorten life
5. With lead-acid battery or lithium battery system, if the old system, there is unplug AC, do not operate the system battery will also consume power, must be according to the instructions, before delivery, turn off the battery function, to prevent excessive power consumption, affect battery life;
6. The system operation work system, refer to the above remarks, if there is no special instructions, generally is 2 minutes of work, rest 18 minutes of short work system, do not exceed the specified use, to prevent product damage or shortening of life;
7. The push rod has rated load, do not exceed the load, to prevent damage or shorten the life of the push rod, resulting in loss;
8. The system connection shall be connected in strict accordance with the system diagram. In general, the wrong connection will not cause product damage.
9. If the customer customized circuit board, their own assembly, need to refer to our "circuit board assembly process precautions", to prevent the assembly process, improper operation, resulting in circuit board damage; Especially the connector part, for the sake of insurance, must be fixed with glue.
